BRIEF DESCRIPTION OF DATA PROCESSING

Károli Gáspár University of the Reformed Church in Hungary (hereinafter: KRE or the University), regularly books accommodation and arranges travel arrangements for its own staff in connection with their foreign assignments and for invited guests (e.g. visiting professors, members of delegations) on the basis of its internal procedures.

In connection with those activities, the responsible department is required to carry out procurement procedures. Due to their specific nature, these procurement procedures involve the processing of a large amount of personal data (in particular: personal data of the natural person making use of the travel). Information on the processing of these personal data is provided in this document.

PURPOSE OF DATA PROCESSING

The processing is necessary for the University's procurement procedures related to accommodation and airline ticket reservations. Accordingly, the purpose of the data processing is to ensure the proper conduct of the procedures.

LEGAL BASIS OF DATA PROCESSING

For the activities covered by this information brochure, the legal basis of the data processing is the legal interest of the University [Article 6 (1) f) of the GDPR]. The data controller has a legitimate interest in ensuring that travel-related purchases are made in accordance with national laws, internal regulations and accounting rules. The processing is necessary and appropriate for the purpose of the processing and does not entail disproportionate restrictions on the rights and freedoms of data subjects.

The processing activity may also involve the processing of special categories of data of the data subject within the meaning of Article 9(1) of the General Data Protection Regulation. Such data shall be processed on the basis of Article 9(2)(a). Explicit consent shall be given by the data subject in the travel document.
