## Laudation of Professor Dr. Matthias Konradt

Professor Dr. Matthias Konradt is Professor Ordinarius at the University of Heidelberg, at the Faculty of Theology, in the area: "Neutestamentliche Theologie I: Exegese und Theologie des Neuen Testaments sowie antikes Judentum", New Testament Theology: Exegesis and Theology of the New Testament – and Judaism in Antiquity.

Professor Konradt was born in 1967 in Bochum, Germany.

Between 1986-1993 he carried out theological studies in Bochum and in Heidelberg. Between 1993-1995 he was the scientific assistant at the University of Heidelberg at the side of Prof. Christoph Burchard.

In 1996 he had his Promotion (PhD).

Between 1996-1999 he was pastor in Bochum, and in 1999 he was ordained as pastor in Westfalen.

Between 1999-2003 he was scientific assistant in the special research area "Judaism – Christianity" at the University of Bonn.

In 2002 he had his Habilitation in New Testament in Bonn.

Between 2003-2009 he was Ordinarius Professor of New Testament at the University of Bern, Switzerland – already at that time he took up scientific relationship with our Faculty of Theology and gave guest lectures for us.

Since October 2009, he is Ordinarius Professor of New Testament at the University of Heidelberg.

Between 2017-2019 he was Vice-Dean at the Theological Faculy in Heidelberg, and between 2019-2021 he was the Dean of the same Faculty.

Professor Konradt has been invited to give guest lectures at prestigious universities, may I mention here as an example that he was invited to give the Kenneth Clark Lectures at Duke Divinity School in Durham, North Carolina in 2024.

Professor Konradt is married to Dr. Beate Konradt, who is the leading librarian of the library of the Faculty of Theology in Heidelberg. Beate is also present here, we greet her here as well in the name of our Faculty.

Professor Konradt is leading editor of the famous journal "Zeitschrift für die Neutestamentliche Wissenschaft" (ZNW).

He was supervisor at 17 doctoral dissertations already successfully defended, and currently is the supervisor of 8 further dissertations.

There are several main areas in New Testament studies, in which he is a leading scholar of our days, just to name a few:

Pauline Epistles – in which area he has published monographs and papers, and currently is working on a monograph on Paul's life, letters and theology and on commentaries on Ephesians and 1Thessalonians.

Among the Gospels, his special focus is on the Gospel of Matthew: Professor Konradt has published not only monographs and numerous articles in this field, but also a major commentary in "Das Neue Testament Deutsch" ("NTD") series, already published also in a second, enlarged edition, and also translated into English and French languages.

Recently, in 2022, his major work has been published: "Ethik im Neuen Testament", Ethics in the New Testament, a 540-page-strong volume in this very important area, which also shows how scientific work is not an end in itself for Professor Konradt, but he serves with his scholarship Christian life today. Although ethics is of the highest importance for the life of the church, it is an area in which we missed such a great work for about two generations; for example, Wolfgang Schrage's "Ethik des Neuen Testaments" was published 40 years before Professor Konradt's "Ethik im Neuen Testament". This recent book of his is also already in the process of being translated into English.

May I here mention only a few titles from Professor Konradt's extraordinarily wide range of writings, in chronological order:
